- Hours of operation are from 8 a.m. to 3 p.m.
- All vendors must be set up by 7:45 a.m. and vehicles moved to designated areas.
- Vendors will not be permitted to bring vehicles into the yard sale area before 3:15 p.m.
- All spaces will be assigned by fairground's management.
- Any tents or easyups must be flame resistant in accordance with NFPA 701 and accompanied with a certificate showing compliance.
- All unsold items must be taken off the grounds by the vendor on the given Saturday.
- All vendors must provide a copy of the Declaration page of their homeowners policy showing \$100,000.00 of personal liability insurance coverage with submission of application.
- The sale of pocket knives, hunting knives, stink bombs is prohibited, as well as any type of item that would be considered a weapon.
- No drug or drug associated paraphernalia may be sold or displayed.
- No dogs, except those for seeing eye purposes, are permitted on the grounds at any time.
- Lethal weapons are not permitted on the grounds.
- The fairground's management reserves the right to interpret, amend or add to the rules and regulations.

**General release and acceptance of rules and guidelines:** I (we), the applicant(s) have read the above rules and guidelines and agree to abide by such. I (we) the applicant(s) release The Great Frederick Fair, Inc. and The Frederick County Agricultural Society, Inc. of and from any and all liability for any injury, loss or damage to any goods or persons which may arise from the occupation and rental of said space by the applicant, and agree to hold and save The Great Frederick Fair, Inc. and The Frederick County Agricultural Society, Inc. harmless of any damages or loss of reason therein.
